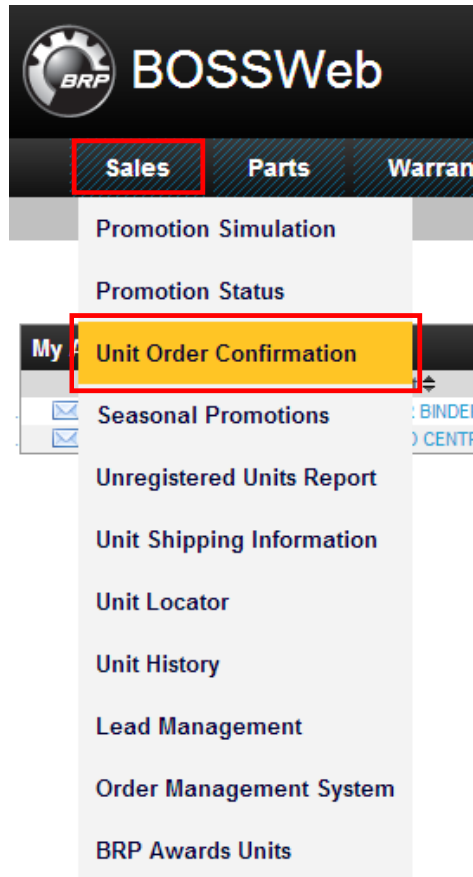

Introduction

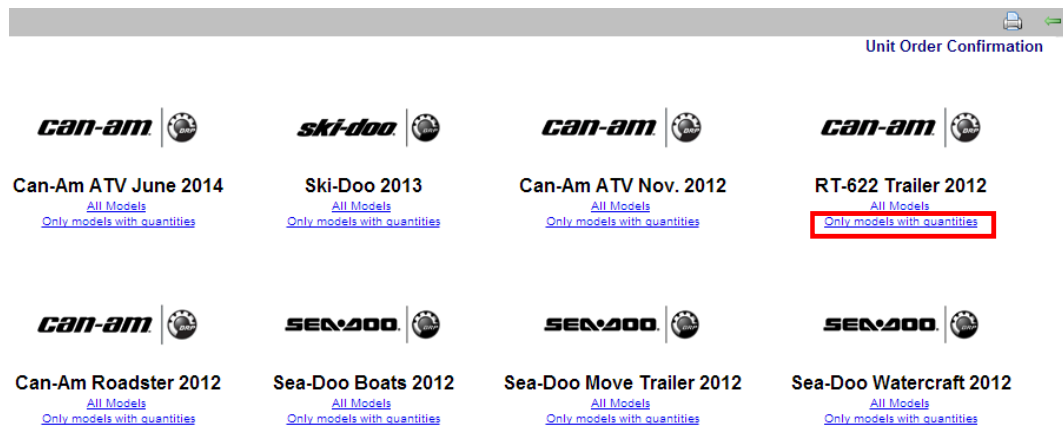


The **Unit Order Confirmation** transaction allows you to access a document showing your annual purchase commitment (Exhibit to dealer agreement) for each product line.

All Products will be shipped according to the prevailing shipping schedule, which may change from time to time at BRP's discretion. Dealer agrees to accept the Products when available from BRP. Financial arrangements with Dealer's financial institution must be acceptable to BRP and adequate to enable Dealer to pay for 100% of order, regardless of delivery date. Products will not be shipped C.O.D.
